## Tier 2 (General): basics

- Sponsored by employer to do a specific job
- Dec 2018 white paper proposes sponsorship by "umbrella organisations" in some sectors
- Min skills level RQF 6 (degree level or higher)
- White paper proposes reducing min skill level to RQF 3 (A level)
- Min salary: for most jobs £30,000 but £20,800 for "new entrants"
- Employer issues Certificate of Sponsorship (CoS)
- Maintenance: £945 for 90 days

# Tier 2 (General): switching from Tier 4 in the UK

#### Concessions for employers:

- No Resident Labour Market Test
- No immigration skills charge
- No cap on Certificates of Sponsorship

#### Concessions for applicants:

- Minimum salary £20,800 not £30,000
- Can usually start work as soon as you have applied

# Tier 2 (General): switching from Tier 4 in the UK

- You have completed a UK Bachelor's or Master's degree; or
- you have completed at least 12 months of study in the UK towards a UK PhD; and
- You studied this course during your most recent Tier 4 visa, or during a period of continuous leave that includes this Tier 4 visa
- If you are or were sponsored by a government or an international scholarship agency, you have their written consent for the Tier 2 application
- Dec 2018 white paper proposes allowing visitors to switch to skilled worker. Only some nationalities.

# Tier 2 (General): application fees

#### Standard application:

- 3 years or less: £704
- 3 years or less, shortage occupation: £464
- More than 3 years: £1408
- More than 3 years, shortage occupation: £928
- Immigration Health Surcharge: £400/year
- Premium application: add £610

# Tier 2 (General): starting work

- If you applied on the basis of studying 1 year of a PhD, you can start work immediately
- If you applied after getting your results, you can start work immediately
- If you applied before getting your results, you can only start work when the Tier 2 visa is issued

# Tier 2 (General): some common problems

- You have not completed a UK degree or 1 year of PhD: you cannot apply
- Employer is not a Tier 2 sponsor: you cannot apply
- Employer is waiting for Tier 2 sponsor license: you may run out of time to apply in the UK
- Employer says they need to see your results before issuing a CoS: may be outdated info, qualification may be a condition of the job altho not visa requirement
- Ad or job spec says you need permission to work in the UK: means when you start work
- Application asks if you have a "work permit": means permission to work in the UK

- The Tier 2 application, starting work: your Tier 2 sponsor

### Tier 4 Doctorate Extension Scheme

- PhD students: 12 month extension
- White paper proposes that in future the 12 months will be "built-in"
- Apply within last 60 days before date of completion. Your Tier 4 sponsor defines what this means for you.
- Comes under Tier 4, not a work category
- Can start work when degree awarded
- After 12 months, switch to Tier 2 (etc.)

## Tier 5 Government Authorised Exchange

- For work experience
- No permanent job
- Generalist, sector based, specific companies
- Listed in Appendix N of the immigration rules
- 1 year or 2 years, depending on scheme

# Tier 5 Youth Mobility Scheme: apply in home country

- Not possible to apply in UK
- Restricted to specific nationalities
- Maximum age 30
- No dependants on the visa
- No dependent children
- Two years, no switching or extending
- Dec 2018 white paper proposes new UK-EU YMS scheme with participating EU countries

  - Husband/wife
  - Same sex civil partner
  - Unmarried Partner
- Long residence

#### Make the most of your Tier 4 visa

- Max 20 hrs/week during term time
- No limit in vacations
- Dissertation period is term time
- No time limit between formal end date of course and end of your visa (usually 2 or 4 months)
- Some restrictions on the type of work

### Make the most of your Tier 4 visa

- No self-employment or business activity
- No permanent full-time job
- No professional sports
- No work as an entertainer
- No work as a doctor or dentist in training
