## **ODI-Fleming Fund Fellows:**

# ODI Fellowship Scheme and Fleming Fund Fellowships in Antimicrobial Resistance

This year we are looking for health economists or economists interested in health for Fellowships sponsored by the UK's Fleming Fund. These Fellowships aim to help key partner countries initiate work on Antimicrobial Resistance (AMR). The Fleming Fund will be active in low and middle income countries (LMICs) across Africa and Asia and is in response to a key recommendation in the UK report chaired by Lord O'Neill, "Tackling Drug Resistant Infections Globally: The Review on Antimicrobial Resistance" in May 2016 (amr-review.org). We encourage applicants who already have a degree of professional experience and applicants from developing countries.

#### Who selects these Fellows?

Together ODI and the Fleming Fund will select the best candidates through an open international competitive process and offer a selection of candidates to each participating institution. ODI will strive to place an institution's most preferred candidate with the employing institution. Formal requests for Fellows must be submitted to ODI by the first week of June 2019.

#### What is being offered?

The partnership will offer highly qualified and motivated early to mid career ODI-Fleming Fund Fellows on two-year contracts with the employing institution commencing in Q3 of 2019.

#### Who will pay for these Fellows?

Fellows will be employed by the institutions they work for and be paid a regular local salary that would be offered to an equivalent local employee. The Fleming Fund will top this salary up to the level offered by the ODI-Fleming Fund Fellowship Scheme. Work will include providing and presenting analysis to support the needs of the AMR Coordinating committees in country as well as working on an AMR project.

## Who manages the work of these Fellows?

Fellows will work according to a job description agreed between their host governments, ODI and the Fleming Fund. Fellows' work programmes will consist of up to 50% of their time on AMR-related issues including work for the local AMR Coordinating Committee and up to 50% of their time on general health economics. Fellows will be managed by and report to local supervisors with annual reporting requirements to ODI and the Fleming Fund.

### Who should be interested in this offer?

This offer is aimed at early to mid career health economists and One Health institutions such as ministries of health, agriculture, environment in LMICs across Africa and Asia, who want to boost their capacity to work on AMR. We encourage applicants who already have a certain amount of professional experience and also applicants from developing countries.


## Who takes responsibility for these Fellows?
